## 2025 Activities Summary

- Installed 2 fish habitat structures, from residents' recycled Christmas trees, on both lakes.
- Restocked the lakes with 155 channel catfish, 100 largemouth bass & 100 hybrid blue gill.
- Constructed and installed 4 new turtle platforms on both lakes.
- Repaired light at Prairie Meadow and Scottsdale entryways and replaced with LED bulbs.
- Studied drainage and erosion control issues for future implementation.
- Encouraged a resident to install a Little Library (RMHOA now has 2)
- Researched and implemented an online dues payment option.
- Cooperated with Friends of Geese and resident volunteers for humane population control of geese on our lakes, treating 9 nests and preventing the hatching of 49 eggs.
- Provided Closing Letters for the sale of 8 homes during 2025.
- Received 8 requests for Architectural Committee review for fence and landscape projects.
- Increased membership in RMHOA's Facebook Group (Robeson Meadows Families: <https://www.facebook.com/groups/RMFamilies>) to 140 members.
- Received 28 submissions from the general Contact form.
- Increased the number of subscribers receiving blog post notifications to 67.
- Held an Easter Egg Hunt & Children's Treasure Swap with over 75 participants.
- Coordinated the neighborhood garage sale in August. A big success again this year.
- Held the 4th Annual Turkey Trot on Thanksgiving Day. Over 50 residents and friends turned out despite freezing temps and a 15°F wind chill, for a 1-mile walk/run around the lakes.
